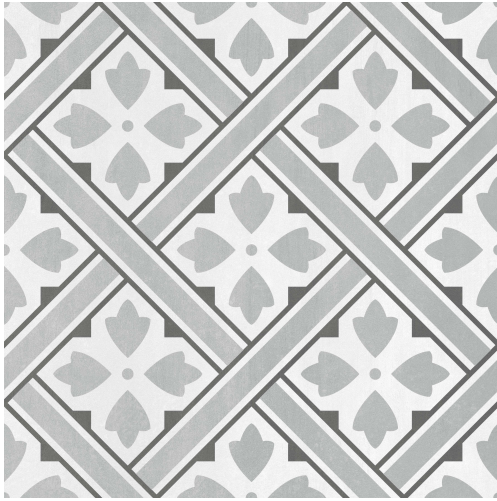

The pendulum test results are displayed in line with The Health & Safety Executive guidelines whereby 0 - 24 represents a high slip potential, 25 - 35 signifies a moderate slip potential and 36+ represents a low slip potential.
